CAPITAL IMPROVEMENT PROJECTS

Highlighted below is a brief summary of some of the capital improvement projects planned for this year. If you have any questions regarding these projects, please call the Engineering Department at (440) 353-0842. There will be more to come in the summer issue of the *Community Connection* including street paving and full-depth concrete repairs.

Barres Road Realignment with Stoney Ridge Road. Final design plans for the Barres Road Realignment Project will be wrapped up by mid-spring with construction anticipated to begin this summer. The project involves realigning approximately 300 feet of Barres Road to meet perpendicular to Stoney Ridge Road and align directly across from Ravenna Drive. The project includes new asphalt pavement with curbs, storm sewer improvements, utility relocation, and new pavement markings.

CAPITAL IMPROVEMENT PROJECTS (CONT'D)

Center Ridge Road Urban Paving. The City is working with the Ohio Department of Transportation to resurface Center Ridge Road from the Elyria corporation limit to the Westlake corporation limit, with the exception of the 2.1-mile section of Center Ridge Road that was recently widened. Construction is anticipated to begin after June 1 and last approximately three months. Two-way access will be maintained during construction. The project will include a new surface course and pavement markings.

Cypress Avenue Roadway Extension. The Cypress Avenue Roadway Extension Project includes the addition of 930 linear feet of new roadway to connect Cypress Avenue to Lorain Road just inside the city limits of North Olmsted. The project seeks to provide better access and create opportunities for future business development. Final design plans have been approved and construction is anticipated to begin this summer.

Mills Road, Stoney Ridge Road and Avalon Drive Roundabout. The Mills Road, Stoney Ridge Road and Avalon Drive Roundabout construction plans have been finalized. Construction will begin at the end of summer and last for approximately three months. The project includes new pavement, curb and gutters, traffic control and landscaping. The roundabout will consist of a “peanut” shape to improve safety and efficiency and eliminate the current intersection’s offset geometry.

State Route 83 and Chestnut Ridge Road Roundabout. The City has secured safety funding from the Ohio Department of Transportation for the design of the State Route 83 and Chestnut Ridge Road Roundabout Project. The new roundabout will eliminate the intersection’s current skewed configuration. The project also seeks to eliminate the need for a traffic signal while improving safety and efficiency. The project includes new pavement, curb and gutters, stormwater improvements, pavement markings and new signage. Construction is anticipated in calendar year 2024.

Case Road Bridge (PID No. 112821). The Lorain County Engineer’s Office is replacing the Case Road bridge over Chappell Creek. The project includes a new bridge structure, approach pavement, new guardrail and traffic control. Construction is anticipated to begin in March and be completed by the end of July. Case Road will be closed at the bridge for the duration of the project. Detour routes will be posted.

Mills Creek North Condos Water Main Replacement. The project includes the replacement of the 6” water main on White Pine Way, Spruce Pine Way, Red Pine Way, and Scotch Pine Way; with a new line south of Mills Road to loop the streets together. The City has retained Northeast Ohio Trenching Services to construct the project. Construction is tentatively scheduled to begin in the spring and last approximately four months.

Lorain Road Water Main Extension. Construction of the Lorain Road Water Main Extension is expected to begin in March and last approximately four months. Work will occur during the day and also during the evening hours. The project includes the extension of a 12” water main from a point east of Lear Nagle Road to a point west of Bliss Parkway, a distance of roughly 2,300 linear feet. The purpose of the project is to remove all of the existing commercial taps from Avon Lake Regional Water’s 30” ETL1 water main on the north side of Lorain Road and add them to the new line.

Mills Road Water Main Extension. The City plans to extend a 10” water main from the Stoney Ridge Road and Mills Road intersection to Stratton Mill Drive, a distance of roughly 1,250 feet. The City has retained KS Associates for the technical design and preparation of construction documents for the Mills Road Water Main Extension Project. Final plans and specifications will be completed in mid-spring with construction anticipated to occur later this year.

Stoney Ridge Road Water Main Extension. The City plans to replace a portion of an existing 8” water main on Stoney Ridge Road from Schaefer Drive to Sandy Ridge Drive, a distance of roughly 1,000 feet. The City has retained Pennoni Associates, Inc. for the technical design and preparation of construction documents for the Stoney Ridge Road Water Main Replacement Project. Final plans and specifications will be completed in mid-spring with construction anticipated to occur later this year.

Mill Creek Conservation and Flood Control. The City will continue moving forward with the Mill Creek Conservation and Flood Control Project. Work planned for later this year includes the acquisition of the property easements needed to convey stormwater to the conservation area along with tree clearing for the retention basin site.

Victory Retention Basin. The City will be performing sediment removal of the Victory Park Detention Basin to re-establish the original capacity of the basin that has been lost over time from sediment accumulation and failing slopes. This project is necessary to reduce the potential for flooding in the surrounding area. Design plans for the basin are currently underway.

Center Ridge Road Sanitary Sewer Extension. Construction of the new sanitary sewer on Center Ridge Road is currently underway. The project will connect to an existing 10” sanitary sewer on Barton Road just north of Center Ridge Road and will extend a new 10” sanitary sewer from Barton Road east to the corporation limit. The project has a scheduled completion date set for June 1 of this year.

Eastview Sanitary Sewer Extension. The City plans to extend an 8” sanitary sewer along Eastview Avenue. The main will begin at the intersection of Ridgeview Boulevard and Hadaway Street and head east for approximately 300’, then south towards Center Ridge Road for approximately 560’. The sewer will allow for future development of the surrounding parcels. Design plans for the project are currently underway with construction expected to occur in the fall.

POLICE STATION UPDATE

Even though we have not yet broke ground for the new police station a lot of work preparing for that moment is happening.

To keep you apprised of the progress, the following has or is occurring:

- The large dirt pile located at the site has been removed thanks in part to our very own Service Department. The dirt was relocated and used to improve the water retention basin located between Grant Drive and the Ohio Turnpike.
- With the removal of the dirt pile, the survey of the site has been completed and additional boring samples have been taken.
- The wetlands located on the site have been determined and government mitigation has been completed.
- City Council has approved the hiring of Architectural Vision Group (AVG) as the architectural firm who will design the interior and exterior of the building. AVG has been in constant contact to insure the building will meet our current and future needs.

In the next couple of months we look forward to:

- Presenting the completed architectural plans to the City's Building Department for their review and approval.
- Hiring a general contractor through the bid process.

RECREATIONAL FIRE PERMITS

Recreational fires require a permit that can be obtained at no cost to the property owner and is valid for the entire year in which it was issued. To obtain a permit, visit www.nridgeville.org/fire.aspx to access the link. When completing your request for the permit, you are agreeing to abide by the permit requirements that are listed on the website e.g., recreational fires shall not be conducted within 25 feet of a structure or combustible material such as homes, sheds, fences, decks; maximum pile size is three feet or less in diameter and two feet or less in height; only burn clean, dry, seasoned firewood and ignite with a small quantity of paper only. Failure to comply, the Fire Department is authorized to order the extinguishment of the fire and may issue a citation under City Ordinance #1620.99.

DISPOSAL OF YARD WASTE

With spring clean-up just around the corner, the following are guidelines for the disposal of yard waste. From **April 5th through November 29th** all yard waste must be placed in compostable brown (*Kraft*) paper bags or if loose, placed in a container that is clearly marked "Yard Waste" but cannot be larger than 32 gallons nor exceed 50 pounds in weight. If too large for bags or containers, any twigs or branches must be in bundles that are tied securely with string or twine (*no wire*) and should not exceed 4 feet in length nor exceed 50 pounds in weight. During this collection period, yard waste will be collected in unlimited amounts each week on your regular trash and recycling collection day, as long as they are contained and placed at the curb according to these guidelines.

While we understand the urge to go outside on unseasonably nice and warm days to get a head start on spring cleaning the yard, please keep these guidelines in mind. Any yard waste that is gathered between December and March each year will either need to be placed in the blue trash cart each week or held until the first yard waste collection for composting in April.
